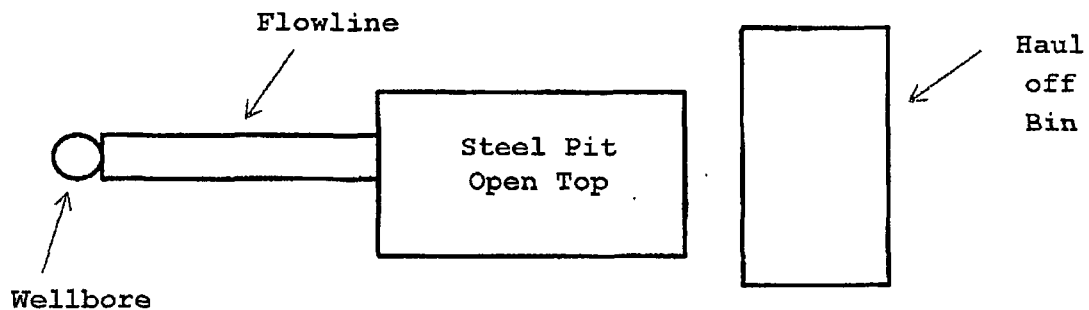

CLOSED LOOP OPERATION, MAINTENANCE AND CLOSURE PLAN

1. One 250 bbl steel pit used to circulate fluids and solids into via flowline connected to wellhead.
2. Vacuum trucks used to haul off circulating fluids.
3. Backhoe used for removal of solid waste into haul off bins.
4. Haul off disposal bin used to haul solid waste to disposal facility.
5. Closure Plan: Haul all fluids and solid waste to disposal facility and remove steel pit.
