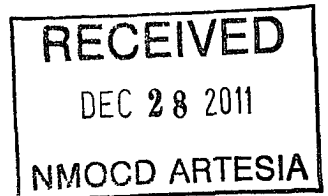
CBS respectfully request recission of the previously submitted plug and abandon procedure submitted on 7-7-2010 for the subject well.
