

11/14/11, drill 7-7/8" production hole to 8460'M, 8063'V 11/19/11. RIH w/ 5-1/2" 17# L80 LTC csg @ 8460' w/ DVT @ 5903' POST @ 3952'. Cmt 1st stage w/ 540sx (158bbl) Super H, circ 171sx (50bbl) cmt to surf. Cmt 2nd stage w/ 670sx (195bbl) IFC, circ 103sx (30bbl) cmt to surf. Cmt 3rd stage w/ 370sx (135bbl) PPC followed by 150sx (36bbl) PPC all w/ additives, circ 60sx (22bbl) cmt to surf. Rel Rig 11/21/11.
