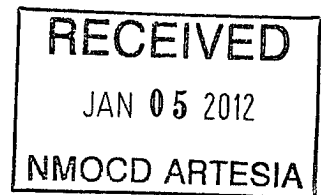

Tailed in with 360 sx Class "C" + 0.2% D46 + 0.2% D201 (yld 1.33, wt 14.8). Circulated 143 sx to pit. Tested casing to 1500 psi for 30 min. WOC 31 hrs 15 min. Reduced hole to 8-3/4" and resumed drilling.
