1/4/12, drill 10-5/8' hole to 4211' 1/5/12. RIH & set 8-5/8' 32# J55 LTC csg @ 4211', cmt w/ 1050sx (350bbl) Light PPC w/ additives, followed by 200sx (48bbl) PPC w/ additives, circ 420sx (140bbl) cmt to surf. Test BOP's to 250# low, 5000#. WOC per BLM Potash requirements.

1/8/12, drill 7-7/8' production hole to 8527M, 8122V 1/12/12. Log well w/ Platform Express. RIH w/ 5-1/2" 17# J55 LTC csg @ 8518' w/ DVT @ 6093' POST @ 4273'. Cmt 1st stage w/ 540sx (157bbl) Super H, circ 310sx (90bbl) cmt to surf. Cmt 2nd stage w/ 630sx (179bbl) IFC, circ 346sx (100bbl) cmt to surf. Cmt 3rd stage w/ 460sx (162bbl) PPC followed by 100sx (23bbl) PPC all w/ additives, circ 57sx (20bbl) cmt to surf. Rel Rig 1/15/12.
