0' to 2500', 12 1/4" hole, 9 3/8" 36# csg. Cmt w/800 sks. Brine water. Est TOC @ surface.

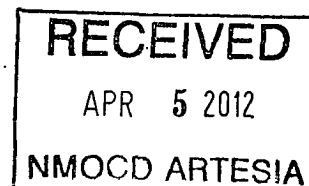
