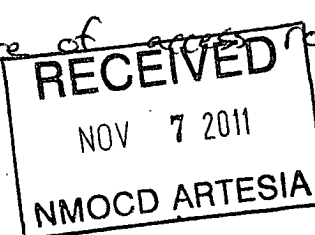

Closed Loop Pad Dimensions 280' x 320'

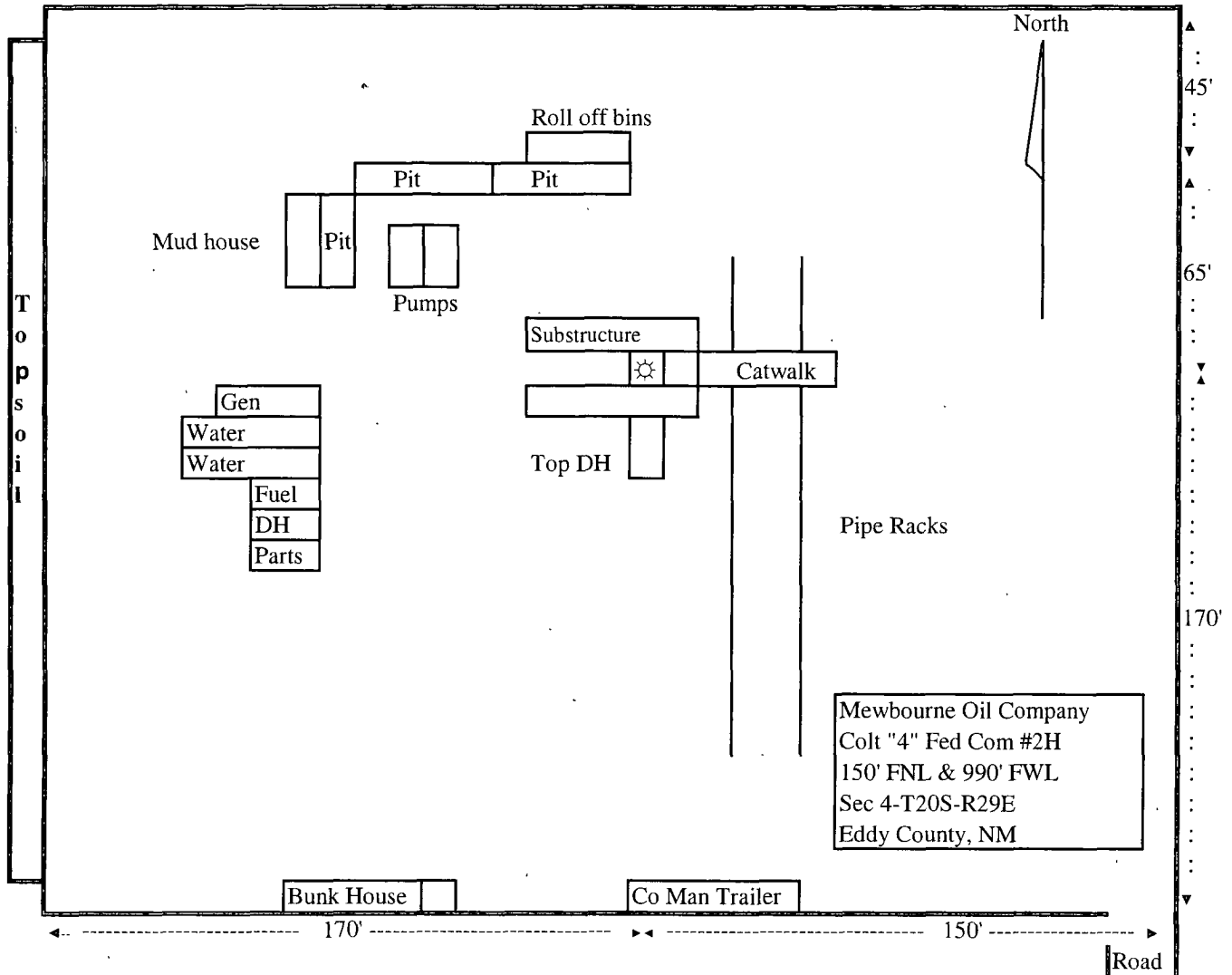
