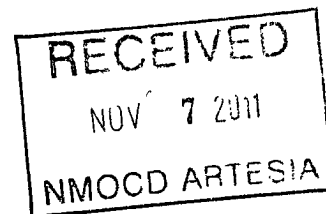

At 8:45 PM 10/12/11 tested csg to 1500# for 30 minutes, held OK. Drilled out with 6 1/8" bit.
