Spudded well on 3/27/12 w/12-1/4" bit. Drilled 12-1/4" hole to 407'. Set 8-5/8" 24# J-55 csg @ 397'. Cmted w/375 sx (503 cf) "C" cmt w/2% CaCl<sub>2</sub> & 1/8# cello flake. Circ 42 sx cmt to pit. On 3/28/12, pressure tested 8-5/8" csg to 1500 psi for 30 min - OK.

Drilled 7-7/8" hole to TD5101' on 4/3/12. Ran open hole logs. Set 5-1/2" 17# J-55 production csg @ 5087'. Cmted lead w/350 sx (665 cf) 35/65 poz "C" cmt w/5% salt, 5# LCM-1, 0.04% R-3, & 0.125# CF & tailed w/550 sx (726 cf) cl "C" cmt w/0.3% R-3 & 1/8# CF. Circ 103 sx cmt to surface. Released drilling rig on 4/4/12. Plan to pressure test 5-1/2" csg before completion operations.
