2/18 - 2/28/12: MI completion equipment. Clean location. Began frac flowback, drill out frac plugs.

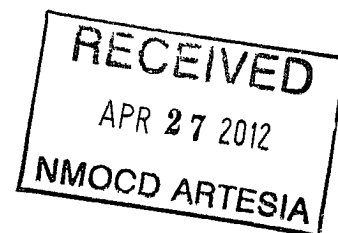
