COG proposes to downsize from 8-3/4" hole to 7-7/8" hole at 6873' MD and drill a 7-7/8" lateral to 11,222' MD. Run 5-1/2" 17# L-80 casing from surface to 11,222' MD with isolation packers in the lateral portion of the hole. A stage packer tool will be installed in the 5-1/2" string at kick off point at approx 6023' MD. The packers will be set and the DV tool opened. The 5-1/2" pipe will be cemented from 6023' MD to surface with: Lead 400sx 35:65:6:C:Poz:Gel w/5% salt, 5pps LCM, .2% SMS, .3% FL-52A, .125pps CF, 2.01yd. Tail 400sx 50:50:2:C:Poz:Gel w/5% salt, 3pps LCM, .6% SMS, 1% FL-25, 1% BA-58, .125pps CF, .3% FL-52A; 1.37yd. 56% excess in open hole, calculated to surface. This is a minimum volume and will be adjusted up after caliper is run.

Summary of Current Status:

- APD and Sundry Approved with Drainhole TD (DHTD) at 11122' MD (6500' TVD).
- 13-3/8" x 9-5/8" x 5-1/2" casing program with 17-1/2" x 12-1/4" x 8-3/4" hole sizes

ORIGINAL PLAN

5-1/2" casing in 8-3/4" hole

Cement 5-1/2" casing from TD to Surface

Cement 5-1/2" casing in the drainhole

Top Glorieta is predicted at 5230'.

REVISED PLAN Sundry dated 4/4/2012:

8-3/4" hole to 6773'. 7-7/8" lateral hole to TD.

Run 5-1/2" 17# L-80 casing to TD. Cement from 6023' to Surface.

Utilize 5-1/2" x 7-7/8" isolation packers on the 5-1/2" casing in the uncemented drainhole.

Conditions of Approval:

The original engineering COA shall remain applicable, with the following inclusions.

1. Setting depth for the 5-1/2" packer tool at 6023' MD is approved.
2. TOC for 5-1/2" casing above the DV tool will be to surface. Operator is responsible to confirm TOC. If cement does not circulate to surface, the Operator is to call the BLM. Operator is responsible to have a remedial cementing plan if one is needed. **NOTE: Additional cement will be required as excess calculates -13%.**
3. Changes to the approved casing program need prior approval if the items substituted are of lesser grade or different casing size. The Operator can exchange the components of the proposal with that of superior strength (i.e. changing from J-55 to N-80, or from 36# to 40#).
4. Changes to the approved cement program need prior approval if the altered cement plan has less volume or strength or if the changes are substantial (i.e. Multistage tool, ECP, etc.).
