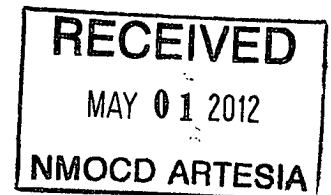

Mixed @ 14.8#/g w/1.34 yd. Plug down @ 2:00 P.M. 03/30/12. Circ 67 sks of cmt to the pit. Tested BOPE to 2500#. At 6:30 PM 03/31/12, tested csg to 1500# for 30 mins, held OK. Drilled out with 8 3/4" bit.
