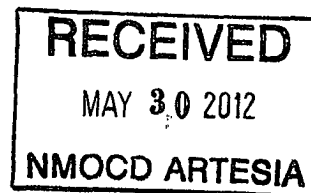

COG Operating LLC rigged up on this well to change out the pump, but found that the csg was split; pumped 55 sx cmt plug @ 6648'; cut & pulled 5 1/2" csg @ 3505'.

Plan to repair well as follows:

- 1) Run dress off mill
- 2) Run concave mill
- 3) Run lead seal csg patch & new 5 1/2" 17# J-55 csg
- 4) Engage csg stump w/patch; set csg in WH
- 5) TIH w/composite bridge plug; set @ ±4700'
- 6) Load & test csg to 500#
- 7) Perforate 5 1/2" csg @ 4315'
- 8) Attempt to circ down 5 1/2" csg
- 9) TIH w/CICR; set @ ±4230'
- 10) Cmt csg; TOH w/tbg
- 11) Run CBL to determine TOC if no circ
- 12) Drill out composite & cmt plugs
- 13) Run prmpg equipment
