Yates Petroleum Corporation proposes to plug and abandon this well as follows:

1. Rig up all safety equipment as needed. No casing recovery will be attempted.
2. Set a CIBP at 8852' with 35' cement on top. This will place a plug over the Morrow perforations.
3. Spot 20 sx plug from 6775' to 6790'. This will leave a plug across the Penn top.
4. Spot 20 sx plug from 5618' to 5813'. This will leave a plug across the Wolfcamp top.
5. Spot 20 sx plug from 4225' to 4420'. This will leave a plug across the Abo top.
6. Spot 20 sx plug from 2039' to 2234'. This will leave a plug across the Glorieta top.
7. Spot 20 sx plug from 1075' to 1270'. This will leave a plug across the Surface casing shoe. WOC 4 hours and tag plug. Re-set if necessary.
8. Spot 35 sx plug from 300' to surface in the 5-1/2" casing and fill the 5-1/2" x 8-5/8" annulus from 40' to surface.

NOTE: Yates Petroleum Corporation will use steel pits and no earth pits

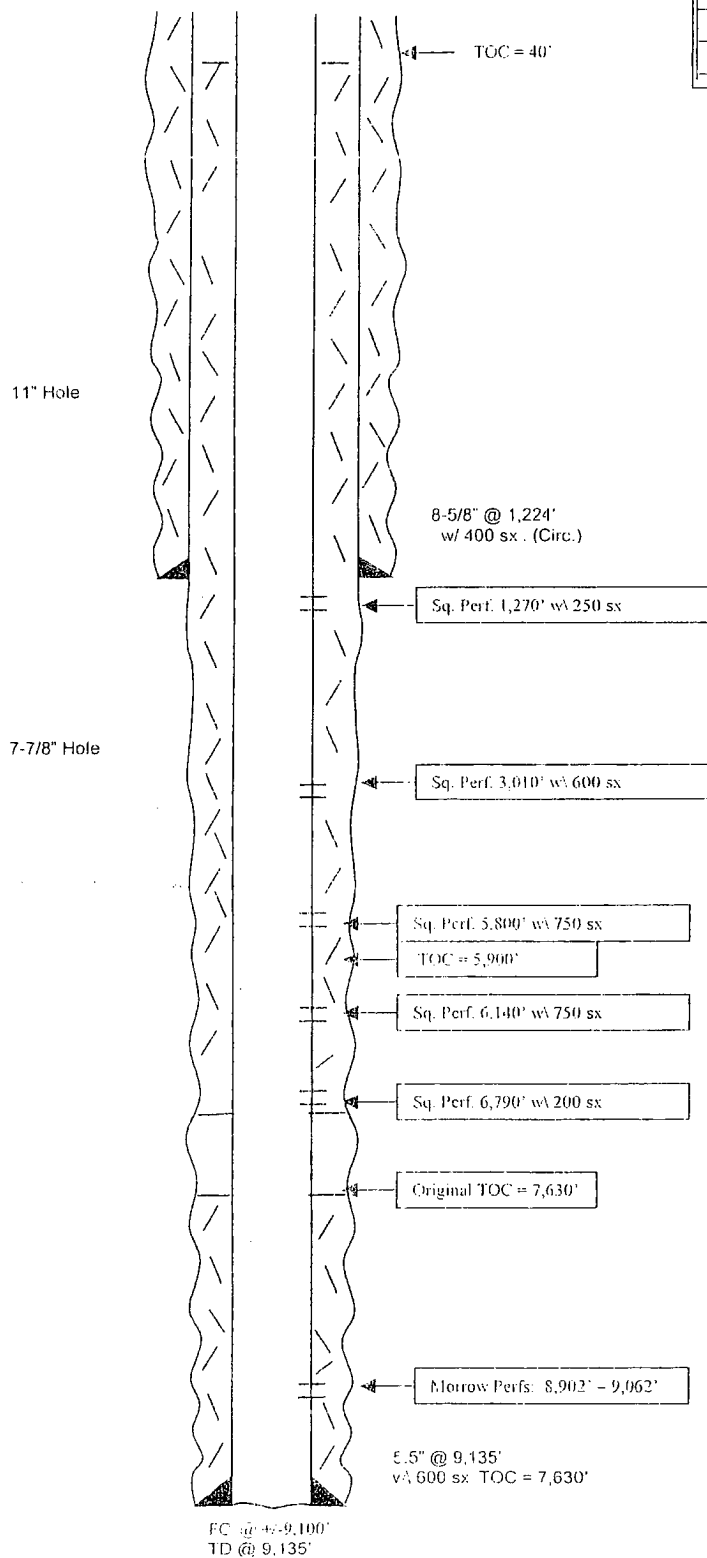

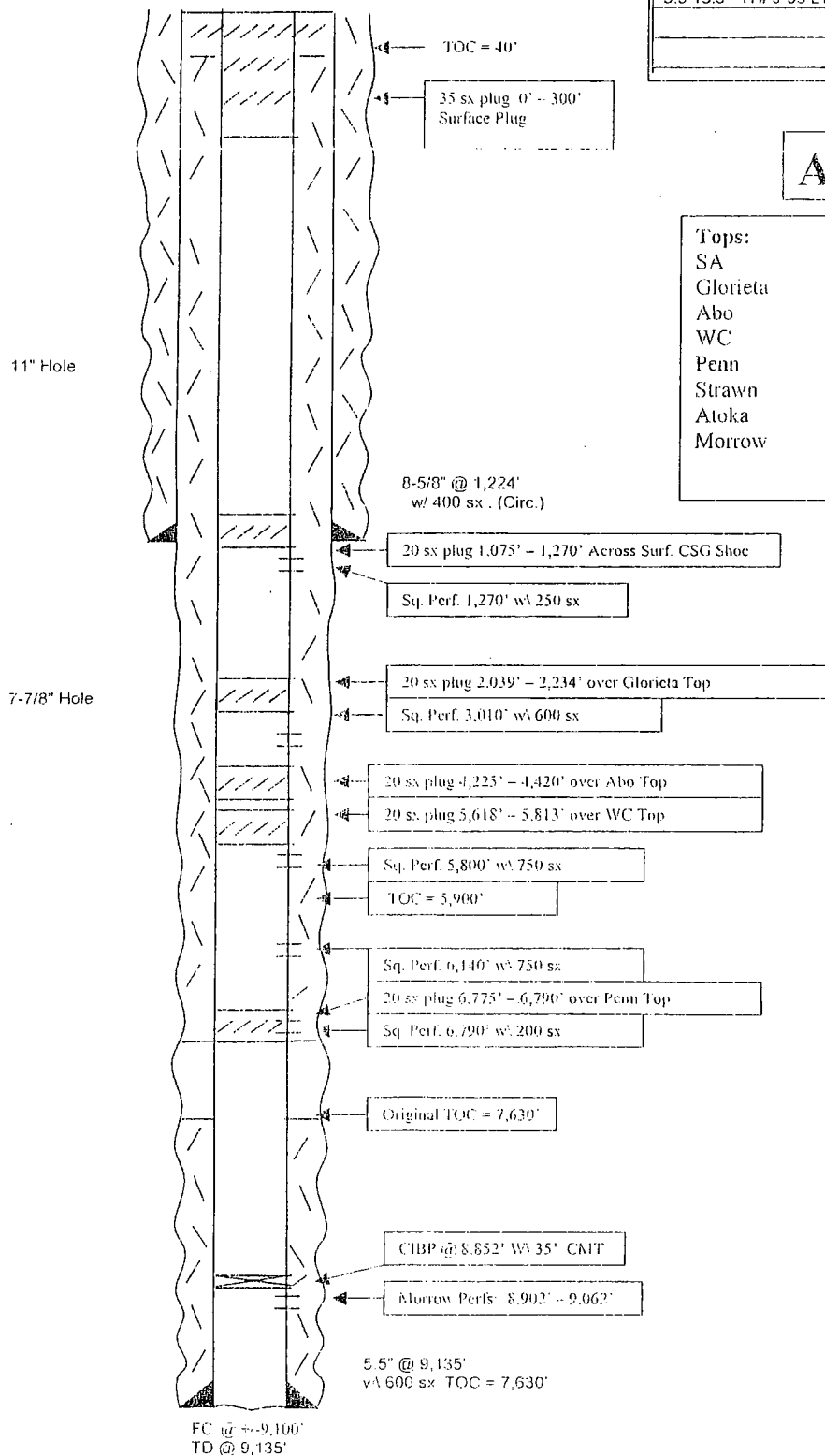
