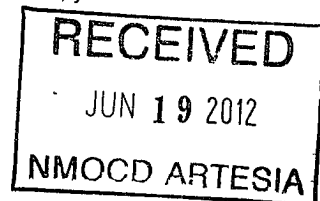

Tail: 200 SKS C+0.1% PF13 Davis Fluid calipers 2097 cubic feet 90% washout
DENSITY = 14.8. YIELD = 1.33. H2O = 6.35. 121 bbls of cement circulated back to surface. Cut off casing and weld on 13 3/8" well head and test 9 5/8" head to 1500 psi for 30 minutes = ok.

Drilled out cement 38 hours after cement in place.
