

- 1) SET 7" CIBP @ 3,050'; MIX X PUMP A 25 SX. OMT. PLUG @ 3,050'-2,950'; CIRC. WELL W/ PXA MUD.
- 2) SET 7" CIBP @ 2,500'; MIX X PUMP A 50 SX. OMT. PLUG @ 2,500'-2,322' (PERFS. X B/ANHY.); WOC X TAG OMT.
- 3) PERF. X ATTEMPT TO SQZ. A 40 SX. OMT. PLUG @ 890'-790' (T/ANHY. X B/SALT); WOC X TAG OMT. PLUG.
- 4) PERF. X ATTEMPT TO SQZ. A 55 SX. OMT. PLUG @ 544'-390' (8-1/4"CSG.SHOE X T/SALT); WOC X TAG OMT. PLUG.
- 5) PERF. X CIRC. TO SURFACE, FILLING ALL ANNULI, A 60 SX. OMT. PLUG @ 100'-3'.
- 6) DIG OUT X CUT OFF WELLHEAD 3' B.G.L.; WELD ON STEEL PLATE TO CASINGS X INSTALL DRY HOLE MARKER.


