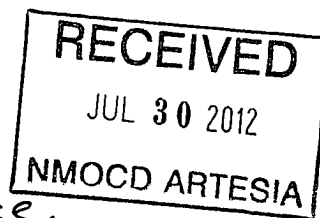

3. POOH with 1" and wait 15 minutes and monitor well for fall back.
4. Top out well with cement
5. Install 4" P & A marker per BLM requirements
