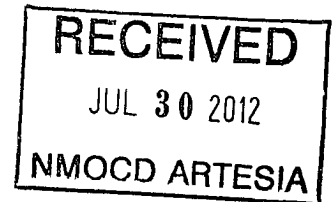

4. Top out well with cement
5. Install 4" P & A marker per BLM requirements.

@ cut-off, 1" cnt to surface, annulus.*
