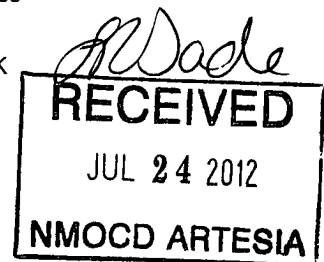

At 5 30 PM 06/22/12 tested BOPE & csg to 1500# for 30 minutes, held OK. Drilled out with 8 3/4" bit.
