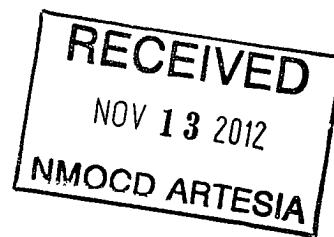

Circulated 83 sks of cement to the pits. At 8:45 PM 10/08/12, tested csg & BOPE to 1250# for 30 mins, held OK. Drilled out with 12 1/4" bit.
