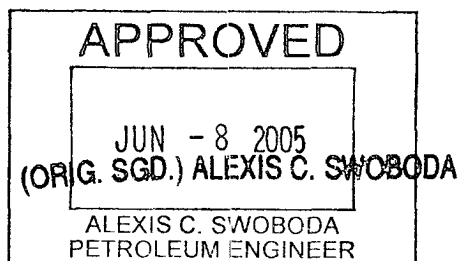

Marathon Oil Company is proposing to install a 5 1/2" liner from surface to approximately 900' from surface. This operation is being proposed to isolate a casing leak that previous operations had found between 616' to 799' from surface.

Once the liner has been installed Marathon will then install rod pumping equipment to return the Upper Perm perms 7512' to 7910' to production.
