Cement with 175 sx Permian Basin Critical Zone + 10 pps gilsonite + 1/4 pps flocele & 300 sx Permian Plus + 1/4 pps flocele + 2% CaCl. Circulate & WOC 27 hrs. Test casing to 1000 psi f/30 min. held ok. Drill 11" hole to 3197'. Drill 7-7/8" hole to 7530'. Ran 150 jts 5-1/2" 15.5#, J-55, LTC & 32 jts 5-1/2", 17#, J-55 LTC casing set @ 7528'. Cement with 620 sx Premium Plus + 2% Zone Seal 2000 w/Nitrogen. TOC by Temp Survey 4880". Release Rig @ 9:00 a.m. 6/17/05. Prep for completion.
