1. Notify OCD 24 hours prior to starting plugging operations.
2. Set CIBP at 2433' w/ 35' cement cap.
3. Circ hole with mud gel.
4. Perf at 1100' squeeze plug 50' below and above base of salt. WOC and tag.
5. Perf at 601' squeeze plug 50' above and below 8 5/8" shoe. WOC and tag.
6. Perf at 60' squeeze cement to surface inside and outside of casing. WOC and tag.
7. Install dry hole marker.


