6/8/05 Set CIBP at 5750' with 35' cement on top. Perforate Wolfcamp 5362'-5370' (48) and Cisco 5462'-5468' (36).  
6/10/05 Acidize Wolfcamp and Cisco w/1500g 7-1/2% acid and 126 balls.  
6/15/05 Frac Wolfcamp and Cisco with 45,000g 65Q CO2 foam and 2500# 100 mesh 20/40 sand. Set 4-1/2" ASI 10K packer with 1.87" on/off tool at 5300'.
