Yates Petroleum Corporation plans to plug and abandon this well as follow:

1. Rig up all safety equipment as needed.
2. Set a 5-1/2" CIBP at 6054' with 35' cement on top.
3. Perforate casing at 4853'. Spot 100' (25 sx) cement plug from 4853'-4753' in and out of casing.
4. Perforate casing at 2170'. Spot 100' (25 sx) cement plug from 2170'-2070' in and out of casing.
5. Perforate casing at 1630'. Spot 100' (40 sx) cement plug from 1630'-1530' in and out of casing. Tag plug.
6. Perforate casing at 60'. Circulate cement down 5-1/2" and up 9-5/8" casing to surface with 15 sx.
7. Install dry hole marker, clean and restore location as per regulated.

NOTE: Yates Petroleum Corporation will use steel pits and no earth pits




