Tagged plug @ 1370'. POH w/ tbg. ND BOP. Perf'd csg @ 520'. Set packer at 10'. Sqz'd 115 sx cement. No pressure and no circulation. WOC. NO TAG. Re-Sqz'd 115 sx cement w/ 1 sx LCM and 2% CACL. WOC.
