DCP PLANT IS AT CAPACITY AND WE MUST HAVE APPROVAL OF THE TIE IN ORDER TO TRANSPORT GAS FROM OUR FEDERAL LEASES TO THE GAS PLANT.

WE CURRENTLY HAVE WELLS SHUT IN AND HAVE 2 WELLS SCHEDULED TO FRAC THE WEEK OF 12/5/12 WITH NO WHERE TO SELL GAS. WE APPRECIATE A QUICK APPROVAL.


