Caza Operating will run a 4-1/2" 11.6 lb per foot P-110 LTC tie back string to remedy problem in 7" ± 4000 ft. PBR is located @ 6537 ft. We will cement string with 240 sks "C" neat 1.32 yield 14.8 ppg for tie back anchor & to cover stage tool. TOC estimated @ 3500 ft from surface.
