Fluid & cuttings coming from drilling operations will pass over the Shale Shaker with the cuttings going to the Sundance Inc / CRI haul off bin and the cleaned fluid returning to the working steel pits.

- 2 180 bbl steel working pits
- 3 75 bbl steel haul off bins
