ConocoPhillips Company has tested the Morrow zone for economical production by flaring to atmosphere on the following dates.

09/13/2005 - SITP was 290# psig & it took 1 hour to pull the well down to the flare back pressure of 26# psig with a flow rate of 86mcf/day for the first hour, then a flow rate of 1.5mcf/day for the next 23 hours for an average of 5.0mcf/day.

09/14/2005 - Flow rate was 1.5mcf/day @ 26# psig.

09/15/2005 - Flow rate was 1.5mcf/day @ 26# psig.

09/16/2005 - Flow rate was 1.5mcf/day @ 26# psig.

09/17/2005 - Flow rate was 1.5mcf/day @ 26# psig.
