The BOP program will be as follows:

After setting 13 3/8" 48# casing at +/- 550' and installing a 3000# casing head, a 5000# double ram BOP and 3000# annular BOP will be installed and tested to 1350# with the rig pump.

After setting 8 5/8" 32# casing at +/- 3500' and installing a 5000# casing head, a 5000# double ram BOP and 3000# annular will be installed. The double ram BOP and choke manifold will be tested to 5000# and the annular will be tested to 3000# with an independent tester.
