Spud well on 12/11/12. Drilled 12-1/4" hole to 383'. Landed 8-5/8" 24# J-55 csg @ 380'. Cmted w/150 sx (224 cf) Thixotropic cmt & 300 sx (405 cf) "C" cmt w/2% CaCl2 & 0.25# CF. Circ 225 sx cmt to surface. On 12/12/12, PT 8-5/8" csg to 1500 psi-OK.

Drilled 7-7/8" hole from 8-5/8" csg shoe to 4305' on 12/16/12. Ran open hole logs. On 12/17/12, landed 5-1/2" 17# J-55 csg @ 4305'. Cmted lead w/200sx (380 cf) 35/65 poz "C" cmt w/1/4#/sx CF, 5% salt, 5# LCM-1 & 0.55% R-3. Tailed w/650 sx (865 cf) "C" cmt w/0.2% CD-32, 0.25#/sx CF, 0.25% R-3. Circ 79 sx cmt to pit. Released drilling rig on 12/18/12. Plan to pressure test the 5-1/2" csg before completion operations.
