

A bond log was ran on the subject well. TOC was indicated at 3850 feet (9 5/8 inch casing shoe is at 3466 feet). Consequently, RKI proposes to pump 150 sks of 35:65 Poz/Class C cement with 5% PF44 (Salt), 6% PF20 (Bentonite Extender), .25% PF46 (Anti Foam), .2% PF13 (retarder) mixed at 12.6 ppg (2.03 cf.sk) down the 5 1/2 inch x 9 5/8 inch casing. This slurry will be displaced to 3100 feet. A bond log will be ran after cementing and WOC.
