1/17/2013 Moved in. Laid down rods. Installed BOP. Started back in with tubing.

1/18/2013 Spotted 25 sx class c cement at 2430'. WOC and tagged at 2274'. Circulated hole with brine and mud. POOH to 1875' and spotted 25 sx class c cement. POOH and SION.

1/21/2013 RIH and tagged cement at 1454'. Picked up packer and isolated holes in 4 1/2" casing between 94' and 125'. POOH and perforated at 738'. Picked up packer and attempt to squeeze perfs. Would not take fluid. RIH to 875' and spotted 25 sx class c cement. SION

1/22/2013 RIH to tag cement. No tag. Repotted 25 sx at 875'. WOC and tagged at 423'. Attempted to pump down 4 1/2" casing to hole between 93' and 125' and up 4 1/2" X 7 5/8" annulus. Pressured up to 500 # and held. Tried to pump down 7 5/8". Would not take fluid. RIH to 125' and circulated cement to surface inside 4 1/2" casing. Cut off wellhead. There was already cement inside 4 1/2" X 7 5/8" annulus to surface. Installed dryhole marker and cut off anchors.
