RIH & set 9-5/8" 40# L80 LTC csg @ 4230' cmt w/ 1250sx (416bbl) Light PPC w/ additives followed by 300sx (71bbl) PPC w/ additives, full circulation, circ 81sx (27bbl) cmt to surface, WOC. Test BOP's @ 250# low 10000# high. 1/2/13 RIH & tag cmt @ 4102', circ hole, pressure test csg to 2650# for 30 min, bled down to 2625#, passed.
