Tailed in with 200 sx Class "C" + 2% S1 (yld 1.32, wt 14.8). Cement circulated to surface. WOC. Tested casing to 1500 psi for 30 min. WOC 21 hrs 30 min. Reduced hole to 7-7/8" and resumed drilling.
