Tank battery has heavily saturated soils on south side of tanks at drain valves. Heavy hydrocarbon and chlroide contamination has run from the tanks south into pasture for approximately 150 feet in at least two distinct flow paths. Heavily saturated soils thorughout this contamination path.

Wellhead contamination is running off across location to the south. Contamination at gunbarrel is running off onto location east and south. Contamination on north side of tanks is migrating east then south across location. Heavily contaminated soils piled near power pole north of wellhead.

Remediaiton is required. Submit C-141 for tank battery release. Contact NMOCD District 2 Environmental Compliance Officer with site ranking and remediation work plan.

Notify NMOCD District 2 Office 48 hours prior to any remediation work or prior to taking samples where results of the samples may be submitted to OCD.
