Lead: 650 sks of Class C ("c" + 4% PF20=2%PF1+.25PPSPF46+.125 PPS PF29). Yield = 1.74, density = 13.5

Tail: 200 sks of Class C ("C"+1%PF1). Yield = 1.33, density = 14.8

Circulated 65 bbls of cement to surface.
