

2/20/13 – RIH with bit and scraper to 1296'. Set a 4-1/2" CIBP at 1230'. Loaded hole and tested to 500 psi. Spotted 100 sx Class "C" Neat cement with 2% CaCl. WOC 4 hrs. Tagged at 548'. Tested casing to 500 psi. Pumped 75 sx Class "C" Neat cement. Circulated to surface. ND BOP. Topped out casing.
2/27/13 – Dug out cellar and cut off wellhead. Installed dry hole marker. Filled cellar. **WELL IS PLUGGED AND ABANDONED.**
