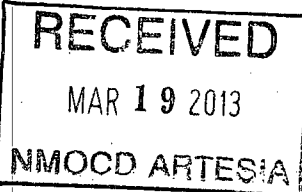

Cemented surface casing--Lead: 775 sacks Class C, yield 1.74 cu. ft per sk., density 13.5, slurry 240 BBLs. Tail: 200 sacks Class C, yield 1.34 cu. ft per sk., density 14.8, slurry 48 BBLs.

Did not circulate cement to surface.
