

Mixed @ 14.8 #/g w/1.34 yd. Plug down @ 10:00 AM 03/17/13. Circ 25 sks of cement to pit. WOC. Tested BOPE to 3000# & Annular to 1500#. At 4:30 AM 03/18/13, tested BOPE & csg to 1500# for 30 mins, held OK. Drilled out with 8 3/4" bit.
