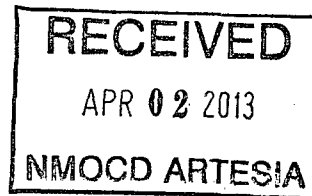

3. POH w/ tubing.
4. PU CIBP and set at 1600' on tubing. 1600' is at the top of the curve.
5. Lay down tubing. Circulate hole with packer fluid.
6. Have OCD witness pressure test to 500# for 30 min.
7. Secure well head w/2' sub.
