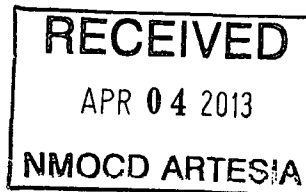

03/17/13..MI & spud 17 1/2" hole. TD'd hole @ 250'. Ran 250' of 13 3/8" 48# H40 ST&C csg. Cemented with 180 sks Thixad "H" with additives. Mixed @ 14.6 /g w/ 1.56 yd. Followed w/300 sks Class C w/2% CaCl2. Mixed @ 14.8/g w/1.34 yd. Plug down @ 3:30 PM 03/17/13. Did not circ cement. Lift pressure @ 118# @ 3 BPM. Ran temp survey indicating TOC @ 145'. RIH with 1" pipe. Tag at 145'. Ran 1" pipe in 3 stages with 75 sks Class C w/3% CaCl2. Mixed @ 14.8#/g w/1.34 yd. Circ 10 sks cement to pit. WOC 18 hrs. At 1:45 AM 03/19/13, tested BOPE & csg to 1250# for 30 minutes, held OK. Drilled out with 12 1/4" bit.
