

Rigged up pulling unit on the well to repair tubing leak. Pulled out of the hole with rods, pump and tubing. Pressure tested the tubing going in the hole. Replaced the joints of tubing that did not hold pressure. Ran in hole with pump and rods. Spaced out the pump and hung the well on. Restored to production, February, 2011.

NOTE: Since a notice of intent was not filed before the work was done, Daniel Sanchez with Enforcement in Santa Fe said to file a subsequent report.
