Considerations for Plugging Quote Bid

- 1. Inspections of roads and locations that may require repair to get equipment to/from job site.
- 2. Inspections, testing or installation of anchors.
- 3. Rental equipment that may be required for job.
- 4. Fresh and brine water requirements for plugging.
- 5. Removal of liquids and solids to approved disposal site.
- 6. Other expenses that may be required to complete job.
- 7. Provide daily estimate cost to District office.
- 8. Upon completion of plugging file C-103 subsequent report with OCD. This is to include cement volumes, cement tags and date well was plugged.
- 9. Provide District office final invoice for approval.

This is not a complete list but a guideline to help in the bid process.
