Mixed @ 12.5#/g w/2.13 yd. Tail w/200 sks Class C Neat. Mixed @ 14.8 #/g w/1.33 yd. Plug down @ 10:45 PM 03/13/13. Did not circ cmt. Ran temperature survey indicating TOC @ 1600'. PU 1" pipe & tag @ 1595'. Cmt in 5 stages w/369 sks Class C w/6% CaCl2. Mixed @ 13.5/g w/1.75 yd. & 180 sks of Thixad Class H. Mixed @ 12.5#/g w/2.13 yd. Circ 21 sks of cmt to pit. Tested BOPE to 3000# & Annular to 1500#. At 7:30 AM 03/16/13, tested csg to 1500# for 30 mins, held OK. Drilled out with 8 3/4" bit.
