Drilled 7-7/8" hole to TD4658' on 4/23/13. Ran open hole logs. Set 5-1/2" 17# J-55 production csg @ 4653'. Cmted w/lead 325 sx (621 cf) 35:65 poz "C" cmt w/5% PF449BWOW, 6% PF20, 0.2% PF13+0, 0.125# PF29, 0.25# PF46, & 3# PF42 & tailed w/600 sx (798 cf) cl "C" cmt w/0.4% PF13, & 0.125# Cello Flake. Circ 215 sx cmt to pit. Released drilling rig on 4/24/13. Plan to pressure test 5-1/2" csg during completion operations.
