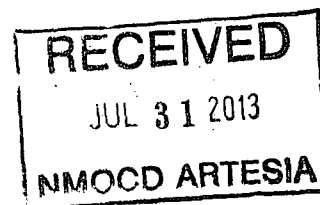

6/10/2013 - Rig up. RIH with tubing to 2363'. Circulate hole clean. Pulled up to 2323'. RIH with new rods and pump, hung well on. Return well to production.
