Drilled 7-7/8" hole to TD4753' on 8/3/13. Ran open hole logs. Set 5-1/2" 17# J-55 production csg @ 4753'. Cmted w/lead 270 sx (513 cf) 35:65 poz "C" cmt w/5% PF-44(BWOW), 6% PF-20, 0.2% PF-13, 0.125# PF-29, 0.25# PF-46, & 3# PF-42 & tailed w/685 sx (904 cf) cl "C" cmt w/0.2% CD-32, 0.25% R-3, 0.25# CF. Circ 85 sx cmt to pit. Released drilling rig on 8/5/13. Plan to pressure test 5-1/2" csg during completion operations.
