8/4/13 - Pressure tested casing to 500 psi for 30 min, held good. Spotted 30 sx Class C Neat cement on top of CIBP. Calc TOC at 5757 ft. Spotted plugging mud from 5757 ft - 5660 ft. Spotted 35 sx Class C cement at 5660 ft. Calc TOC at 5445 ft. Spotted plugging mud from 5445 ft - 3718 ft. Spotted 35 sx Class C Neat cement at 3718 ft. Calc TOC at 3503 ft.  
8/5/13 - Pressure tested to 2900 psi, bled down to 2750 psi in 30 min. Tagged TOC at 3579 ft. Perforated Yeso 3380 ft - 3506 ft (57). Apply 500 psi on casing. Pumped 8000g 20 percent gelled HCL acid. Overdisplaced acid with 100 bbls 2 percent KCL. ND BOP. 2-7/8 inch 6.5Lb L-80 tubing at 3336 ft.


